**Membership Definitions:**

**QFCRE:** Qualified Field of Commercial Real Estate

**Full Member:** means an individual in a QFCRE who is employed full-time in a professional position, the primary responsibilities of which are in a QFCRE. Full Members have voting rights.

**Affiliate Member:** means an individual who works substantially full time in either (i) a business that provides a service or product to a QFCRE, or (ii) a QFCRE, but not at a professional level. Member applicants from companies that primarily contract as subcontractors for construction activities will be considered Affiliate Members, except where the applicant has a professional license. Affiliate Members have voting rights.

**Civic Member:** means an individual who is currently involved in local or regional government, or employed by other public agencies, universities or other educational institutions or not-for-profit organizations. Civic Members have voting rights.

**Retired Member:** means an individual who was previously a Full Member but is no longer working full time.

**Student Member:** means an individual who is currently enrolled within an undergraduate post-secondary QFCRE.

**Dual Member:** means an individual who is currently a Full Member of another CREW Chapter.

All prospective Members must demonstrate support of women in Commercial Real Estate.

# CREW Sask Application Form

By signing in the space provided, the applicant acknowledges that eligibility for CREW Sask Association Inc. membership will be reviewed by the CREW Sask Association Inc. ### Mandatory Requirements for application to be reviewed and processed:

- A. Please attach **one (1) letter of reference** from an individual (it may be another CREW Sask Member) with whom you have had business dealings with in the commercial real estate industry. The reference letter should confirm your professional responsibilities and the number of years of experience you have in a QFCRE (a member of the CREW Sask membership committee reserves the right to contact your reference);
- B. Your **current, up-to-date resume or biography**;
- C. **Contact information for your current employer** to verify current roles and responsibilities; and
- D. **Cheque or e-transfer in the amount of \$500 for Full and Affiliate Memberships, \$300 for Civic, Retired and Student Memberships, \$250 for Dual Memberships**, payable to CREW Sask Association Inc.\*

All applications must be complete and accompanied by a reference letter and payment in order to be considered / processed.

\*Please note that memberships are renewable on January 1st of each year. Membership and the participation in activities are non-transferable and non-refundable. **Membership (new members only) may be subject to a discount after July 1.** New members registering after October 1 may receive the remainder of the calendar year free when paying for the following full year of membership, please contact the Membership Chair to confirm the applicable membership type and fee before submitting your application.
